**NOTICE OF LOCAL RULE 2016-5 REQUEST FOR PAYMENT ON ACCOUNT FOR
COMPENSATION AND REIMBURSEMENT OF EXPENSES OF PROSKAUER ROSE
LLP, CO-COUNSEL FOR DEBTORS, FOR THE PERIOD
DECEMBER 1, 2009 THROUGH DECEMBER 31, 2009**

TO: The United States Trustee, and All Parties on the Clerk’s Service List.

1. Proskauer Rose LLP, counsel to the debtors and debtors-in-possession (collectively, the “Debtors”), has filed an application for payment on account, a copy of which is attached hereto. The Application covers the time period from December 1, 2009 through December 31, 2009 and requests allowance and payment of fees in the total amount of \$81,187.61. This total is comprised as follows: \$77,620.80 (80% of the fees for services rendered) plus \$3,566.81 (100% of interim expenses incurred).

2. Any party receiving this Notice may file an answer, objection or other responsive pleading to the Application with the Clerk of the United States Bankruptcy Court for the Eastern District of Pennsylvania, 900 Market Street, Suite 400, Philadelphia, PA 19107-4299, on or before twenty-one (21) days from the date of this Notice. A copy of any answer, objection or other responsive pleading filed with respect to the Application must be served upon Proskauer Rose LLP at the address set forth below. **Pursuant to Local Rule 2016-5(f), any objection must identify the objector, state the basis of the objection, and identify the amount of the requested payment that is objected to and the amount that is not objected to.**

To the extent objections are filed, Proskauer Rose LLP will certify same to the Court and request that the Debtors pay 80% of the fees requested and 100% of the expenses described in the Application that are not objected to.
