**NOTICE OF MOTION, RESPONSE DEADLINE,  
AND HEARING DATE**

With the exception of Debtor, Philadelphia Media Holdings, LLC, the above-captioned debtors each filed voluntary chapter 11 petitions for bankruptcy on February 22, 2009. Debtor, Philadelphia Media Holdings, LLC, filed a voluntary chapter 11 petition on June 10, 2009. Together, the above-captioned debtors are referred to herein as the “Debtors.”

The Debtors’ chapter 11 cases are being jointly administered under L.B.R. 1001-(2) as Complex Chapter 11 Cases.

On February 5, 2010, the Debtors filed the following motion (the “Motion”):

- (a) Motion of Debtors for Entry of an Order Authorizing Rejection of Certain Executory Contracts

This Motion is to be heard, in the ordinary course, by the Honorable Stephen Raslavich on February 23, 2010, at 10:30 a.m. (prevailing Eastern time), in Courtroom 4, United States Bankruptcy Court for the Eastern District of Pennsylvania, Robert N.C. Nix, Sr. Federal Courthouse, 900 Market Street, Philadelphia, PA 19107.

1. If you do not want the court to grant the relief sought in the Motion or if you want the court to consider your views on the Motion, then on or before the hearing on February 22, 2010, you or your attorney must do all of the following:

- (a) file an answer or objection explaining your position with the bankruptcy clerk's office at the United States Bankruptcy Court for the Eastern District of Pennsylvania, 900 Market Street, Suite 400, Philadelphia, PA 19107;

If you mail your answer to the bankruptcy clerk's office for filing, you must mail it early enough so that it will be received on or before the date stated above; and
