**NOTICE OF REQUEST FOR PAYMENT OF FEES AND REIMBURSEMENT OF ECKERT SEAMANS CHERIN & MELLOTT, LLC FOR THE PERIOD SEPTEMBER 1, 2009 THROUGH SEPTEMBER 30, 2009, PURSUANT TO LOCAL RULE 2016-5**

TO: The United States Trustee, and All Parties on the Clerk’s Service List.

1. Eckert Seamans Cherin & Mellott, LLC (“ESCM”), counsel to the Official Committee of Unsecured Creditors, has filed its application for payment on account, a copy of which is attached hereto. The Application covers the time period from September 1, 2009 through September 30, 2009 and requests allowance and payment of fees in the total amount of \$32,044.58. This total is comprised as follows: \$31,629.20 (80% of the fees for services rendered) plus \$415.38 (100% of expenses incurred).
